2009-2010

1. Entries will be accepted ONLY from members of the Loyal Order of Moose in good standing attested by the Lodge Secretary.
2. The tournament will be governed by USBC, sanctioned tournament rules unless waived below. Any bowler who is not an USBC member shall purchase a card before bowling, Men and Women \$20.00.
3. No bowlers will be allowed to participate who for any reason have been refused membership in the USBC.
4. Any man who is not a paid-up member of the Loyal Order of Moose will be considered an ineligible bowler and any woman who is not a paid-up member of the Women of the Moose will also be considered an ineligible bowler. All scores rolled by an ineligible bowler shall be voided and will forfeit the right of any prize money. There will be no refund of entry fee in any event in which an ineligible bowler participates.
5. Handicaps based on 80% on difference between bowler average and 200. Bowlers will use their highest sanctioned 2009-2010 league average based on 21 or more games in any one league. If no 2009-2010 average, bowlers will use their 2008-2009 average based on 21 or more games. Bowlers having no average will bowl scratch. Any bowler falsifying his average will be considered an ineligible bowler and rule 4 will apply. Failure to use the correct average shall disqualify score if submitted average is lower than correct average thereby resulting in a lower classification and more handicap. Prize winnings shall be based on the submitted average if it is higher than the correct average. However, correction in average may be permitted up to the completion of the first game of the series. USBC Rules 319a-2 and 319d regarding the reporting of the tournament prize winnings and ten or more pin increase in average will be waived. Current season average based on 21 games at the time of bowling of the current year.
6. The Tournament manager reserves the right to re-rate the bowler's average before entrant bowls. If the re-rated bowler's average is not accepted by the bowler, the entry fee shall be refunded. "USBC" rule 319a-3 and Rule 319e will apply to all bowlers.
7. No bowler will be entered more than once in any event. However, in case of emergency, a substitute bowler from the Host Lodge area will be allowed to participate more than once. A man must substitute for a man; a woman must substitute for a woman. No bowler allowed to place more than once on the single's event prize list.
8. To bowl in singles or doubles, you MUST bowl both.
9. Entries will close midnight, August 1, 2010.
10. NO ENTRY WILL BE ACCEPTED UNLESS PAID IN FULL.
11. No team or individual bowling in this Tournament is to be compensated for any entry fee, travel fares or expenses incurred because of the Tournament, either directly or indirectly, from any Lodge Treasury of the Loyal Order of Moose or Women of the Moose.
12. Prize checks will be returned to Lodge Secretary signed entry blank.
13. All entrants must have their USBC card from the state of Ohio.
14. All other rules not covered will be in strict accordance with USBC.
15. Check in time will be 45 minutes before scheduled bowling.
16. Pacers will not be allowed in this tournament.
17. Bowlers arriving late will be allowed to bowl, but start with the frame when they are ready to bowl. No scores allowed for the frames missed.
18. Trophies or jackets will be awarded as follows: Lodge, Team, Doubles, Singles (prizes based on total number of teams) 1st place team - 4; doubles - 2; singles - 2; = 8 Trophies or jackets. (If more than 80 teams.)
19. Separate prize list for men and women in singles division.
20. There will be no picture taking while any bowling is in progress.
21. Under no circumstances shall a bowler be allowed to keep their own score. Nor shall a family member be allowed to keep score for their own family.
22. There shall be no limit to the amount of Handicap allowed in this tournament.
23. Any protests affecting eligibility or general playing rules must be filed in writing to the OSMBA Executive Board before the tournaments prize payments are made. The Board's decision will be final unless an appeal is made in accordance with USBC Rule 329.
24. Prize fund checks will be voided after one-hundred twenty (120) days.
25. Prize Ratio: One prize for each 6 entries or major fraction thereof in team, doubles and singles events.

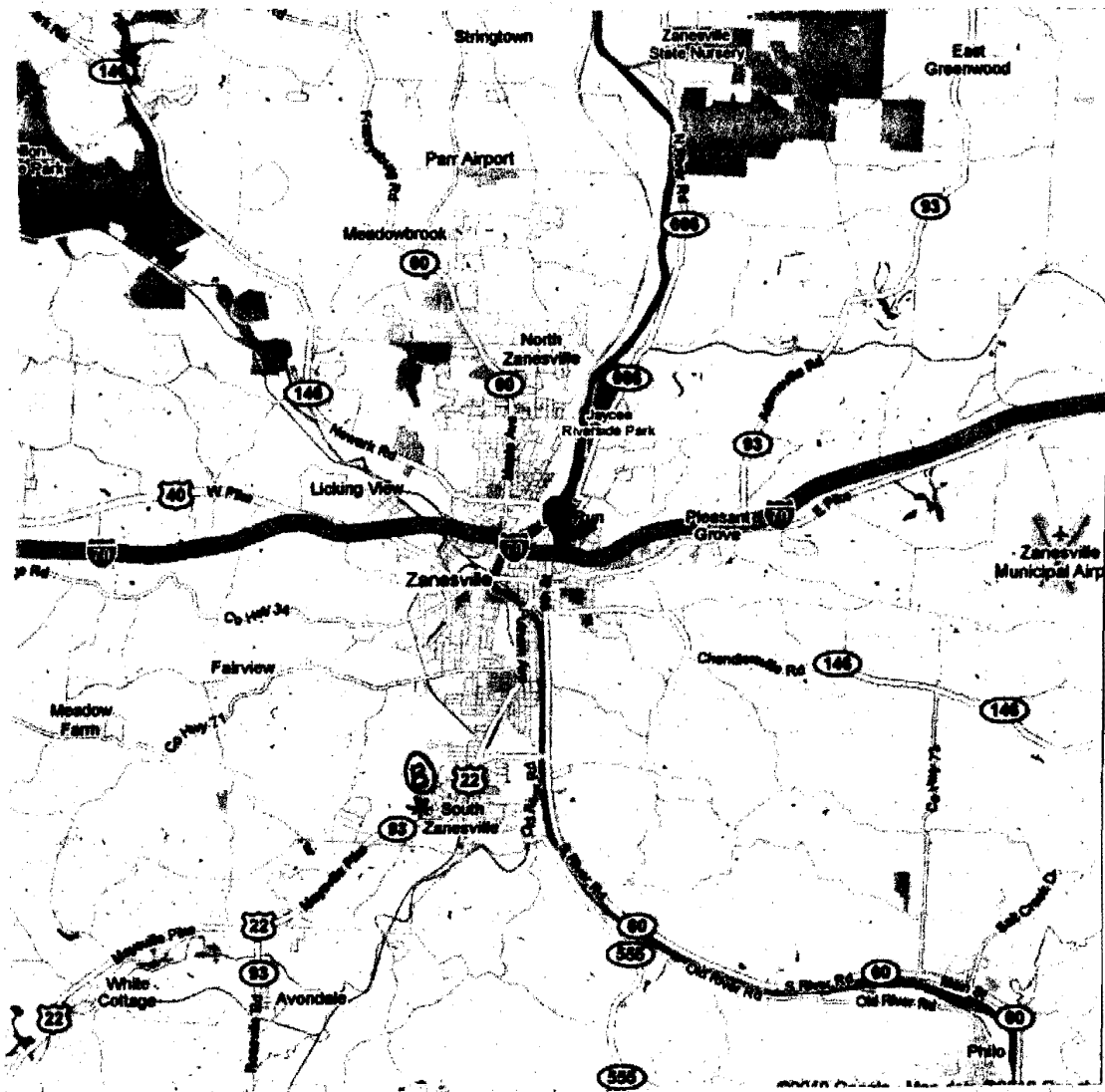
