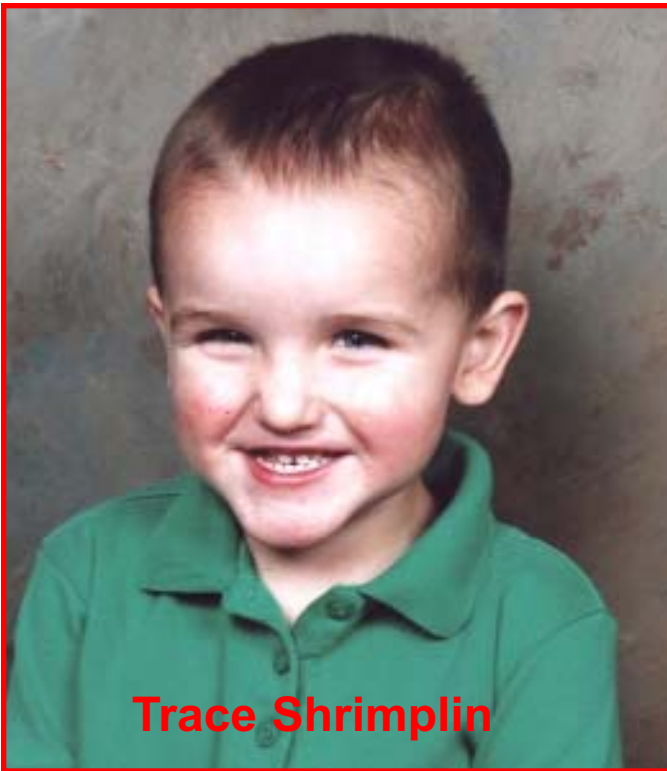

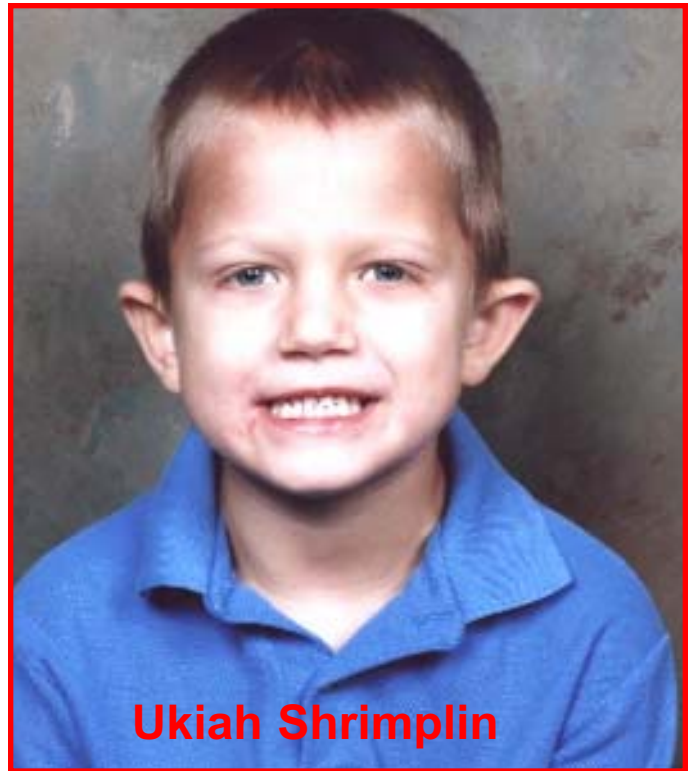

  - b) checks must be made to **Moose Charities**, and Secretary Sipes will forward them
  
- **SPECIAL OLYMPICS, TENT TOWN, and INTERNATIONAL SPECIAL OLYMPICS**
  - 1) OSMA Tent Town - make check payable to **OSMA**, earmark “**Tent Town**”
  - 2) Special Olympics Ohio - make check payable to **Special Olympics Ohio**
  - 3) International Special Olympics - make check payable to **Moose Charities** - footnote “**Special Olympics**”
  
- **OHIO SPECIAL PROJECT**
  - a) mail a monthly check payable to **Moose Charities**
  - b) semi-annual check payable to **Moose Charities** Earmark for “**Ohio Fieldhouse Project**”
  
- **V.A.V.S.** -- Checks made payable to **OSMA** and footnoted **V.A.V.S.**

We'll also get this checklist out to you again before Mid-Year. Remember to make your checks out correctly, payable to Moose Charities or to OSMA, and designate which fund on the memo line.

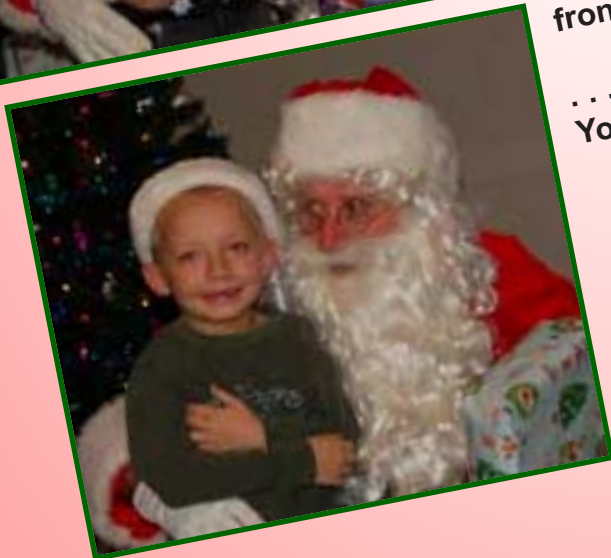

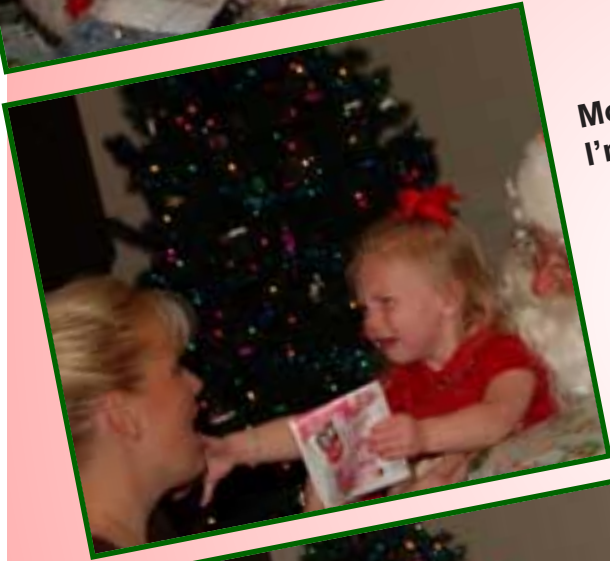
